- Youth Volunteer Application (obtain from ministry head)
- Signed Code of Conduct for Youth Workers and Volunteers
- Two reference forms

References: Have two *non-custodial* adults fill out a reference form. Some suggested persons to ask: teacher, school leader, employment supervisor, volunteer supervisor outside of Holy Name of Jesus or a family for whom you babysat.
